(7) **The State Defender shall coordinate the collection and dissemination of statistical data** and make such reports as are required of the divisions, develop plans and proposals for further development of a statewide public defender system in coordination with the Mississippi Public Defenders Task Force and to act as spokesperson for all matters relating to indigent defense representation.

Data is NOT a “tripwire”

- If data indicates we are not meeting a performance measure or goal we have to ask WHY?
- Is the measure or goal attainable or a good measure?
- Are there factors outside of our control causing or contributing?

What is [data] research?

The systematic investigation into and study of materials and sources in order to establish facts and reach new conclusions.

Who is a researcher?

Academic faculty
Research organization
Consultant
Doctoral student

Performance budgeting

- Outputs – number of parents represented
- Efficiencies – cost per parent
- Outcomes - % change in number of children in care in targeted counties compared to statewide change

I don't care about saving \$ - I want to preserve families!

- Increase the number/rate of reunifications
- Reduce TPR filings
- Reduce reentry post reunification
- Reduce median length of time in foster care

Why track Defender Data

- People don't really know what we do –they certainly don't know what we do outside of court
- Saying "I'm overworked and underpaid" isn't working
- CPS tracks kids not our clients and events or outcomes not what we do
- MYCIDS is not reliable

Key Findings Section

- Moreover, the current training procedures may need to be re-visited with an emphasis on the importance of consistent and accurate data entry.
- Some court employees may not be aware of the importance of entering information into MYCIDS and the purposes for which the information may be used by the policy makers and other key stakeholders.
- For example, one court employee reported that she "didn't know this would actually be used."

What can we tell from SSR analysis?

- They looked at two potential impacts: 1. time case was open and 2. time child was out of home and found:
- 1. The impact of parent representation in both pilot and comparison counties on time that the CPS case is open was not statistically significant.
- 2. comparison of combined pilot and comparison counties together further indicated that cases with parent representations had significantly fewer days that the child was placed out of the home.

Caseload/workload

- An attorney should assure that adequate time is dedicated to each case. To maintain a manageable workload, a fulltime parents' representation attorneys should limit their caseload to between sixty (60) and one hundred (100) cases at any given time. Support staff assistance, travel time required if serving more than one county, experience level of attorney and whether the attorney is part of a multidisciplinary representation team must be considered in determining where in this range an appropriate caseload lies for an individual attorney. A part time parent's representation attorney should limit their caseload proportionately to ensure that other cases do not interfere with counsel's obligation and commitment to Parent Representation Program cases.
