Mississippi Code Ann. Section 43-21-201 requires attorneys, appointed by a youth court to more than ten (10) cases a year to represent a child, to complete annual juvenile justice training that is approved by the Mississippi Office of State Public Defender and the Mississippi Commission on Continuing Legal Education. Six (6) hours is the required amount of training per year.
